UofG Support & Provision for Care-experienced Students

Corporate Parenting 2014 >

The Children and Young People (Scotland) Act, 2014 named Universities and Colleges as *Corporate Parents*, meaning they had a **legal responsibility** towards every child who is looked after by a Local Authority, and every young person, up to the age of 26, who was, at age 16 or beyond, but is no longer, looked after by a local Authority.

Corporate Parenting is described in the legislation as:

(T)he formal and local partnerships needed between all local authority departments and services, and associated agencies, who are responsible for working together to meet the needs of looked after children and young people.

AND

An organisation's performance of actions necessary to uphold the rights and safeguard the wellbeing of a looked after child or care leaver.





Sector-wide Commitment to Care-experienced Learners



Commission on Widening Access (CoWA) Final Report: A Blueprint for Fairness, 2016

- Recommendation 21: Those with care experience, who meet the access threshold should be entitled to the offer of a place at a Scottish university. Entitlement should also apply to those with care experience who have had to take a break from higher education and wish to return.
- Recommendation 22: The Scottish Government should replace student living costs loans with a non-repayable bursary and provide a more flexible package of student support for learners with a care experience.



Universities Scotland - Working to Widen Access, 2017

- Care experienced learners will be guaranteed an offer of a place at university if they meet minimum entry requirements.
- Commitment put in place by Scotland's 18 HEIs for entry in AY 2020-21



SAAS support for Care-experienced Students AY 2017-18

- Care-experienced Student Bursary (Age cap removed in AY 2020-21)
- Additional +1 year of funding
- Summer Accommodation Grant



SFC's National Ambition for Care-experienced Students & Care-Experienced National Policy Group

- In line with wider CoWA targets, the National Ambition outlines SFC's commitment to equal outcomes for careexperienced students and their peers by 2030.
- <u>SFC Policy Group</u> includes representatives from WhoCares? Scotland, CELCIS, SAAS, and Care-Experienced Regional Forums, and is there to ensure that SFC meets targets as set out in the National Ambition.
